## E. <u>DISCUSSION ITEMS</u>

Discussion regarding Wastewater Master Plan Population Projections by HERWIT.

District Engineer Harris – Provided the details regarding the Wastewater Master Plan population projections related to the flow for all residents, projected growth for Residential, Office and Business Park, and Commercial. There was discussion regarding the projected growth and flows. The plan is to provide this item at the next Water and Wastewater meeting.

2. Discussion regarding Wastewater Master Plan update/input with Stantec.

Stantec Senior Principal, Water – Steven Beck – Provided the details of the Wastewater Master Plan related to the update of flows and loads and method of Denitrification. There was discussion regarding the population, flows, loads, and the need to do an analysis and bring back to the next Water and Wastewater meeting.

3. Discussion regarding the Diffuser update and discussion on next steps by HERWIT.

District Engineer Harris – Provided the details regarding the Diffuser analysis, options from Worley Parsons related to rebuilding the Diffuser in some manner, and the need to reevaluate. There was discussion regarding the Diffuser rebuild and a California Environmental Quality Act (CEQA) Consultant. The recommendation from District Engineer Harris is to obtain proposals for the rebuild of the Diffuser, Stantec related to the permitting of the NPDES Permit and evaluation to the Regional Board, and a CEQA Specialists for construction issues.

District Engineer Harris – Stated that the proposals for the Diffuser will be provided at the next Water and Wastewater meeting and then provided to the Full Board.

4. Discussion regarding Water Main Replacement for Edgeview Drive.

Water and Wastewater Manager Koehne – Provided an update and pictures regarding the Water Main replacement for Edgeview Drive related to a water leak, the cost for the repair, relocating the water main to the middle of the street, the need to resolve as soon as possible, and adding this item to the CIP. There was discussion regarding the process of relocating the water main and adding the item to the CIP.

**5.** Discussion regarding the Revised Budget for the Newport PLC and SCADA Upgrade. District Water Engineer Shobe – Provided the details regarding the budget and the bids for the Newport PLC and SCADA Upgrade. There was discussion regarding the budget related to the Newport PLC and SCADA Upgrade.
