- NPDES Permit schedule update, DRAFT Permit sometime in May. There was discussion regarding the NPDES Permit.
- UV Disinfecting update regarding the Master Plan.
- Denitrification update and handout regarding the data (additional test labs CalTran, McCampbell, and FGL) for Nitrite and Ammonia. There was discussion regarding the additional test labs, a DRAFT Memo, possibly schedule a special meeting, cost of the project, BOD (food), and Master Plan timeframe. The discussion continued regarding Plant No. 1, Plant No. 2, alternative to Methanol, research septic tank companies, and a receiving station cost (approximately \$300,000).

3. Update Regarding Facility Security.

Project Manager Sadler – Provided an update regarding the security system; 3 phases – Phase 1. Automatic gate; Phase 2. Card readers on all doors; Phase 3. Cameras. There was discussion regarding the timeframe and the budget for the project.
