

Water and Wastewater Update

District Engineer Harris – Provided an update on the Wastewater Projects;

- Operation and Maintenance Manual (O&M) received two more chapters from Stantec (staff is currently reviewing), 30 total chapters, completion by June or July 2019.
- Diffuser Project first step is permitting process and contracted with Worlev Parsons.
- Wastewater Master Plan tentative completion by July 1, 2019.
- NPDES Permit under review with the Regional Board, schedule for the project, financing plan, and finish Master Plan.

There was discussion regarding the financing plan, compliance plan, completion date (online) by December 31, 2022, cost of the project, flow changes, and lab testing.

Water and Wastewater Manager Koehne - Provided an update regarding projects on the Water side;

- PLC Upgrade at Newport Water Treatment Plant (Willow Lake PLC complete). There was discussion regarding the location of the Water Treatment Plant on Newport and Well No. 7.
- Update on Well No. 4A and Well 2 Project.
