1. Fiscal Year 2023 Financial Report.

Presented by Finance Manager Margaret Moggia.

- Interest income earned will be allocated across all the funds.
- Water received \$77,272 in interest income.
- Wastewater received \$87,137 in interest income.
- Community Center received \$14,045 in interest income.
- Landscape received \$12,722 in interest income.
- Zone 9 received \$2,539 in interest income.
- Edgeview Drive project was completed in 2023 with an approximate spend of \$158K
- On-going Water projects include Marina Drive, Newport and Willow Filter Repair, and Well 8.
- On-going Wastewater projects include Diffuser Project and the Denitrification Project.
- On-going Landscape projects include Clipper Drive, Parks, and Streetscapes.
- Cash Balances/Reserves at June 30, 2023: Bond Fund (Restricted) \$8.9 Million, Checking \$3.8Million, and Money Market \$18.2 Million.
- Look ahead for 2024: Annual Audit is underway, Prop 68 Grant Submission for Cornell Park, Update Rate Study for Water Rates, and Update of Financial Policies.
