D. PRESENTATIONS

1. Financial Update for FY 2022-2023

Presented by Finance Manger Julie Carter.

- The second installment of money from the County will arrive April 19, 2023.
- First month of interest income from Five Star Bank was \$17,000.
- Pantages pulled permits for four lots.
- The 2021-2022 audit is complete.
- There was an increase in water leak repairs and maintenance.
- Pool revenue was \$7,500.

Vice-Chair Graham asked for clarification on how the Pantages community center fee monies could be spent. General Manager Breitstein will investigate the matter.

1. Community Center Outdoor Lighting.

Presented by Parks and Recreation Supervisor Monica Gallo.

• Two contractors were contacted to assess the lighting needs. One quoted \$1,230. The second contractor verbally stated they could do it for the \$250 service call fee plus \$125/hr. but did not give a quote in writing.

2. Community Center Fencing.

Presented by Assistant General Manager Allan Cantando.

- On March 11, 2023, there were trespassers on the Community Center property.
- Staff recommend fencing be replaced to secure the pool area as well as Community Center grounds.
- The cost to fence the south side of the property is \$11,000. The cost to fence the tennis courts could be \$7,000.

Vice-Chair Graham would like to discuss the Employee Retention Act at a future meeting.
