**HONORING BERNEY SADLER FOR HIS
DEDICATED SERVICE TO DISCOVERY BAY CSD**



WHEREAS, first and foremost, Berney Sadler and his family have been residents of the Town of Discovery Bay Community Services District in Contra Costa County for nine years; and

WHEREAS, Berney was born in Montgomery, Alabama and lived in Prattville, Alabama in the same house for twenty-five years; and

WHEREAS, in 1986, upon graduating high school, Berney went to work for the City of Prattville in their wastewater treatment plant to begin a lifelong career in the water and wastewater industry; and

WHEREAS, Berney's career path took him to Indiana in 1992 where he went to work for the Frito Lay wastewater plant; then to Swift Bacon's wastewater plant in 2002; then to Guam in 2004 to work as a wastewater supervisor for the Guam government; then back to the states in 2008 to build a new wastewater facility for the City of Rifle, Colorado; and in 2009 he went to work for Veolia North America in Gresham, Oregon as an Operations Manager; and

WHEREAS, in 2011, Berney became Veolia's Operations Manager for the Town of Discovery Bay Community Services District's water and wastewater facilities; and

WHEREAS, Berney, his wife Missy and his five children made their home in Discovery Bay, became involved in community events and volunteered their time and energy to make life better in the District; and

WHEREAS, Berney has announced his retirement from the water and wastewater industry effective June 4, 2020, and will relocate to Logansport, Indiana to spend more time with his family and become a commercial and residential landlord and operator of a beverage establishment; and

WHEREAS, such beverage establishment is the "Neighborhood Bar and Tavern," where everyone knows your true name, including his, which is "Willie Bernard Sadler Junior;"

NOW, THEREFORE, BE IT RESOLVED that we, the Board of Directors of the Town of Discovery Bay, hereby approve this proclamation thanking and honoring Berney Sadler for his nine years of dedicated service to the Town of Discovery Bay.
